Subject:-Registration of manufacturers and traders of psychotropic substances on the CBN Online Portal and new format of quarterly returns for psychotropic substances along with modalities of submission- reg

The Central Bureau of Narcotics (CBN) is one of the premier law enforcement agency in the country and the also the regulator of trade of Narcotics Drug and Psychotropic Substance and international trade of Controlled Substance under NDPS Act, 1985. The CBN is also the Competent National Authority (CNA) for United Nations three international Conventions.

- 2. It is to inform that this Bureau has issued a Public Notice dated 22.08.2024 for registration of manufacturers of psychotropic substances on the CBN Online Portal (<a href="www.cbnonline.gov.in">www.cbnonline.gov.in</a>) and also has prescribed new format of quarterly returns to be submitted by the registered companies along with modalities of submission. The copy of the said public Notice along with new format of quarterly returns are enclosed.
- 3. The Public Notice is of vital importance to the trade who are dealing in Psychotropic Substances. As the Drug Controller General of India (DCGI) is the coordinating agency for activities of the state Drug Control Organizations. The state Drug Control Organizations regulate the manufacture, sale and distribution of all Drugs. Therefore, it is requested to circulate this Public Notice amongst the state Drug Control Organizations to sensitize their licensees for compliance. The Public Notice may be publicized on your website as well as on websites of state Drug Control Organizations for wider reach and compliance.

## PUBLIC NOTICE

## Amendment to Public Notice F.No.XVI/5/13/O/OSR/2024 dated 05.08.2024

Reference is invited towards this office Public Notice dated 19<sup>th</sup> October, 2023 related to CBN Online Portal, wherein it was advised to all the companies to submit profile and register on the **CBN Online Portal** (www.cbnonline.gov.in). The process of registration in video format is available under LMS section on www.cbnonline.gov.in.

- 2. Your attention is also drawn towards Rule 65 of the NDPS Rules, 1985 which mandates a person who has been issued licence to manufacture of psychotropic substance, to mandatorily register with the Narcotics Commissioner for each of the substance in the form and manner as may be specified by the Narcotics Commissioner. Earlier, such registrations were done through offline mode till 25th October, 2023 and since, then such registrations are being done only through the CBN Online Portal.
- 3. It has come to notice that many companies who are dealing in Psychotropic substance and registered with the Narcotics Commissioner under the Rule *ibid*, have not registered themselves on the CBN Online Portal till date. All such previously registered companies but yet to be registered on CBN Online Portal are advised to register themselves on the said Portal latest by 30th September, 2024. The previous registrations of the companies who fail to register themselves on the CBN Online Portal by 30th September, 2024, are deemed to be cancelled.
- 4. The Rule 65 (2) of NDPS Rules, 1985 mandates submission of Quarterly. Returns by the registered parties with the Narcotics Commissioner in such form and manner as specified by the Narcotics Commissioner. However, it has come to notice that many companies are not submitting Quarterly Returns in the prescribed format and also not adhering to prescribed timelines.
- 5. In view of this, a **new format of Quarterly Returns** for psychotropic substance is devised and the same is enclosed along with this Public Notice. There are 05 category of Quarterly Returns- **Manufacturers of Bulk**, **Manufactures of Preparations**, **Traders of Bulk**, and **Research &**

Development. All the companies registered with Narcotics Commissioner on the CBN Online Portal are directed to file/submit the returns in the prescribed proforma on the dedicated mail ID (online.returns@cbn.nic.in) in single PDF (signed & attested) and also Excel sheet before the last day of the month following the Quarter till this facility gets fully functional in CBN Online Portal. The Quarterly Returns shall be submitted separately for Bulk Drug and Preparations for each psychotropic substance. A separate return has also to be filed for Research & Development for each psychotropic substance. The submission of Quarterly Returns in new pro-forma shall be from 3rd Quarter i.e. July-September of 2024.

6. It is to note that the Quarterly Returns submitted after the due date or not in the prescribed format shall not be considered as submitted/filed for the purpose of Rule 65 (3) of the NDPS Rules, 1985 and the same may contemplate the provisions of Rule 65(5) of NDPS Rules, 1985.
