**Sub: Adoption of "Online National Drug Licensing System" (ONDLS) for Manufacturing & Sales Licensing in the UT of J&K – Regarding.**

**\*CIRCULAR\***

The Department in its endeavor to provide better services to the stakeholders became the first Organization to switch over to the PAN India portal designed by CDSCO. The ONDLS module provides a common platform to grant regulatory clearances in respect of Sales & Manufacturing Licensing / subsequent approvals.

The said initiative is an attempt of the Union Government to reduce Regulatory Compliance Burden as also to secure uniformity , transparency , accountability , build data base besides providing a conducive environment for the stakeholders engaged in various activities in the Pharma Business.

The above portal is not integrated with State Pharmacy Council, so far as Licensing of Retail / Wholesale establishments is concerned. Of late, the Pharmacy Council of J&K has reported that some persons are indulging in unfair practice by uploading in-genuine documents on the online portal of J&K Pharmacy Council. It has further been informed that upon scrutiny, such papers are found fake.

The Licensing Authorities (Retail / Wholesale) of UT discharging statutory duties under the Drugs & cosmetics Act, 1940 & Rules thereunder are impressed upon to verify the genuineness of bonafide claims of applicants viz-a-viz Registration as Pharmacist from the website of J&K Pharmacy Council viz [www.jkpc.in](http://www.jkpc.in) which has an updated list(s) of all candidates who have been granted Registration as Pharmacist in the UT of J&K henceforth to defeat the designs of unscrupulous elements seeking regulatory clearances on the basis of fake credentials.
