Pursuant to selection made by the Jammu and Kashmir Service Selection Board vide No. No.SSB/Secy /Sel/ 40/2019/3111-17 Dated 16.05.2019 conveyed to this Organization by the Administrative Department (Health and Medical Education, J&K) vide communications No. HD/Drugs/49/2019 Dated 18.02.2020, Sanction is hereby accorded to the temporary appointment of Ankush Kumar S/o Gopal Dutt R/o Danoh Hiranagar, Kathua (Open Merit) as Senior Laboratory Technician under Divisional Cadre Jammu in the Pay Level-6D (35800-113200), against the available vacancy, subject to following condition:-

- a) The appointee shall join in the office of Drug Analyst, Combined Food and Drug Laboratory, Jammu within a period of 21 days from the date of issuance of this order. In case the candidate fails to join within the stipulated period of 21 days, his appointment shall be deemed to have been cancelled *ab-initio*, without any further notice.
- b) The appointee shall be allowed to join only on production of the following certificates in original:-
  - i. Academic qualification certificate.
  - ii. Matriculation / Date of Birth Certificate.
  - iii. Health Certificate issued by the standing Medical Board.
  - iv. Permanent Residential Certificate.
  - v. Certificate from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
  - vi. Any other certificate as may be required under rules.
- c) The appointment in Divisional Cadre is non-transferable from one Divisional Cadre to another Divisional Cadre.
- d) The appointee shall be on probation for a period of two years.
- e) The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents are received from CID and other agencies.

- f) If on verification, character antecedents of the appointee are found adverse or the certificates produced by the appointee are proved fake or forged his appointment shall be deemed to have been cancelled ab-initio without any further notice.
- g) The appointment is without prejudice to the outcome of any petition pending in any competent Court of Law.
- h) The appointment shall be governed by new pension scheme.
