Whereas, in compliance with the said CAT directions, the presentation of Mr Mushtaq Abbas Zakir and joint representation submitted by the stakeholder (FSOs) were examined in detail vide this office Order No. FADA-Leg/7/2022-05(131335) dated 13.11.2025 wherein the claim of Mr Mushtaq Abbas Zakir with regard to seniority has been found devoid of merit.
