Whereas, the Administrative Department (Health and Medical Education, J&K) vide No. HD/Drugs/56/2018 Dated: 11.10.2018 advised this office to serve a final notice of 07 days to the address of the candidate and thereafter, if he fail to join within the stipulated time , then cancel the candidature of the candidate; and

Whereas, this office vide No. DFO/Estt/651/4359-63 Dated: 17.10.2018 served a final notice to the said candidate to join within seven days from the date of issuance of notice, failing which it will be presumed that you are not interested to join; and

Whereas, Mr. Sajad Ahmad Ganie S/O Ab. Qayoom Ganie R/o Repora Namthall, Budgam again failed to join within the stipulated period of 07 days.


